Harbor Safety Committee Chairman, Mario Munoz

Mario called the meeting to order, led the Pledge of Allegiance and made general announcements. Marine industry Day is going to be May 21, 2026 at the Higgins Hotel in New Orleans. We are looking for sponsorships as well as planning and event support.

USCG Sector New Orleans, CAPT Gregory Callaghan

Captain Callaghan provided updates for Sector New Orleans and highlighted recent events. Please be tracking the new cybersecurity requirements including the first annual cybersecurity plan audit for vessel and facility operators.

As a result of efforts made within the HSC, the USACE has installed new signage to address communications issues with boats come from the Algiers Lock into the river. The Vessel Agent Handbook product is now available. LCDR Booth can be reached at christopher.w.booth@uscg.mil if you have any questions.

USCG Headquarters is evaluating VTS services in multiple port systems around the country. There will be a presentation to stakeholders on the river, likely in February, to begin the process for our VTS. The goal is to increase reliability and expand services.

It is now Carnival Season, and the Tier 1 Security Operations period will begin on Muses Thursday and end on Fat Tuesday. Anticipate typical Tier 1 security zone regulations. Sail250 events will take place in New Orleans May 28-June 1. There will be a variety of tall ships and military vessels involved, and more information will be forthcoming.

There are currently three openings for VTS Watchstanders, and the application is open until January 12.

Bar Pilots – Captain Jason Mott

The channel is in good shape on the Bar Pilot route, and some real progress has been made on the ATON situation. Captain Mott also gave an update on the Small Vessel Safety Initiative working group.

Crescent Pilots – Mark Nelson

Things are great, mat laying operations on the Crescent route are going well.

NOBRA Pilots – Captain Steve Wall

The low water is affecting some shallow draft anchorages, and recent fog events have been impacting some transits. They are working to minimize fog-related delays and otherwise all is well.

Federal Pilots – Michael Fulcher

The Federal Pilots are managing transits around fog, low water, and mat sinking operations as needed.
